ADDENDUM

The 23rd October, 2025

No. DMETR-16012/1/2021/185-189.— In addendum to the Government Notification No. DMETR-16012/1/2021 dated 30th September, 2021 following changes are made in regards to the execution of bond by candidates (In Service and others) while taking admission in different Post Graduate Medical Courses in the state and Outside the state are as follows :

1. The Clause 2 (i) "After completion of any Post Graduate Courses, the candidates shall have to serve in any hard/interior secondary care health institutes of the State as a functional Specialist, for three (3) years. After completion of three (3) years of service as per bond provision, the direct as well as in-service doctors will be released from bond condition" will now read as **"After completion of any Post Graduate Courses, the candidates shall have to serve in any hard/interior secondary care health institutes of the State as a functional Specialist, for two (2) years. After completion of two (2) years of service as per bond provision, the direct as well as in-service doctors will be released from bond conditions."**
2. The Clause 2 (ii) "Monetary Penalty for defaulters for not serving the state for three (3) years after completion of course shall be an amount of ₹ 1,00,00,000 (Rupees one crore only). The Pass Certificates, College Leaving Certificate or any other certificate in custody of authority shall be retained and will be released only after compliance to the provisions in bond" will now read as **"Monetary Penalty for defaulters for not serving the state for two (2) years after completion of course shall be an amount of ₹ 50,00,000 (Rupees fifty lakh only). The Pass Certificate, College Leaving Certificate or any other certificate in custody of authority shall be retained and will be released only after compliance to the provisions in bond"**.
3. The Clause 3 (i) " After completion of any Post Graduate Courses, the candidates shall have to serve in any hard/interior secondary care health institutes of the state as a functional Specialist, for three (3) years. After completion of three (3) years of service as per bond provision, the direct as will as in-service doctors will be released from bond condition" will now read as **"After completion of any Post Graduate Courses, the candidates shall have to serve in any hard/interior secondary care health institutes of the State as a functional Specialist, for two (2) years. After completion of two (2) years of service as per bond provision, the direct as well as in-service doctors will be released from bond conditions."**
4. The Clause 3 (ii) "Monetary Penalty for defaulters for not serving the state for three (3) years after completion of course shall be an amount of ₹ 1,00,00,000 (Rupees one crore only). The Pass Certificates, College Leaving Certificate or any other certificate in custody of authority shall be retained and will be released only after compliance to the provisions in bond" will now read as **"Monetary Penalty for defaulters for not serving the state for two (2) years after completion of course shall be an amount of ₹ 50,00,000 (Rupees fifty lakh only). The Pass Certificate, College Leaving Certificate or any other certificate in custody of authority shall be retained and will be released only after compliance to the provisions in bond"**.
