#### **NOTIFICATION**

The 14th October, 2025.

No. HOME-11022/83/2024-HM-SECTION-A-HM/10140.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post (s) of the Scientist- 'B' (Scientific Officer), Group-A Gazetted and Scientific Assistant, Group-B, Non-Gazetted, Non-Ministerial in the Directorate of Forensic Science under the Government of Arunachal Pradesh, namely;

- 1. Short title and commencement: (1) These rules may be called the Scientist-'B' (Scientific Officer), Group-A Gazetted, Scientific Assistant, Group-B Non-Gazetted, Non-Ministerial Recruitment Rules, 2025.
  - (2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
- 2. These rules shall apply to the posts as specified in column 1 of the Schedule I and II annexed to these Rules.
- 3. **Number of posts, classification and Level in the Pay Matrix:** The number of posts, their classification and the level in the Pay Matrix attached thereto shall be as specified in columns 2 to 4 in the scheduled aforesaid.
- 4. **Method of recruitment, age limit and other qualifications etc:** The method of recruitment to the said post, age limit, educational qualifications and other matter relating thereto shall be as specified in columns 5 to 13 of the schedule aforesaid.
- 5. Disqualification: No person,
  - (a) who has entered into or contracted a marriage with a person having a spouse living, or
  - (b) who having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said posts.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rules.

- 6. **Power to relax:** Where the Governor of Arunachal Pradesh is of the opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and observing the procedures as prescribed under OM No. AR-89/2012 dated 6th March, 2013 and in consultation with the Arunachal Pradesh Public Service Commission relax any of the Provisions of these Rules with respect to any class or category of persons.
- 7. **Repeal and Savings:** All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these Rules.

Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to be provided for the Arunachal Pradesh Scheduled Tribes (APST) and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.

#### **NOTIFICATION**

#### The 24th October, 2025

No. SIPR-67/2024/193.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of Director Information and Public Relations Recruitment Rules, 1981, except as respect things done or omitted to have been done before such supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post of Director, Information and Public Relations, Group - A, Gazetted under the Department of Information and Public Relations, Government of Arunachal Pradesh, namely; -

- 1. Short title and commencement: (1) These Rules may be called the "Recruitment to the post of Director (Information and Public Relations), Rules, 2025".
  - (2) They shall come into force on the date of thier publication in the Arunachal Pradesh Gazette.
- 2. These rules shall apply to the posts as specified in column (1) of the schedule Annexed to these Rules.
- 3. **Number of Posts, Classification and Pay Matrix :** The number of the posts, their classifications and the Pay Matrix attached thereto shall be as specified in column (2) to (4) of the schedules aforesaid.
- 4. **Method of Recruitment, age limit and other qualifications:** The method of recruitment to the posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the schedules aforesaid.
- 5. Disqualification: No person
  - (a) who has entered into or contracted a marriage with a person having a spouse living, or
  - (b) who having a spouse living has entered into or contracted a marriage with any person, shall be eligible for the appointment to the post.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. **Power to Relax**: Where the Governor of Arunachal Pradesh is of the opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and in consultation with the selection Board relax any provisions of these rules with respect to any class or category or person.
- 7. **Repeal and Saving :** The Recruitment Rules for the post of Director Information and Public Relations Recruitment notified vide notification No. IPR-138/80 dated 13th May, 1981, amended from time to time is hereby repealed.

Provided that any order made or action taken under the rules so repealed, shall be deemed to have been validly made or taken under the corresponding provisions of these rules.

Nothing in these rules shall effect reservation/relaxation of age limit and other concessions required to be provided for the Arunachal Pradesh Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.
