No. AGRI/11016 (14)/3/2023.—In exercise of the power conferred by proviso to Article 309 of the constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the “**Agriculture Development Officer/Agriculture Officer (Plant Protection), Recruitment Rule, 2019**” in the Department of Agriculture under the Government of Arunachal Pradesh, namely: -

1. **Short title and commencement:** (i) These rules may be called “**The Agriculture Development Officer/Agriculture Development Officer (Plant Protection)**” (amendment)” recruitment Rules, **2025**.
- (ii) They shall come into force on the date of publication in the Arunachal Pradesh Gazette.
2. **Amendments to the Principal Rules:** In column numbers of the schedule of the Principal Rules, against the existing entries, the following entries shall be deleted.
- “In column number 7,10 and 11 of the schedule, the term **Accredited to ICAR shall be deleted**”.

NOTIFICATION

The 28th October, 2025.

No. DA/I/13/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the Recruitment to the posts of Arunachal Pradesh (Finance and Accounts Officer/Treasury Officer, Group A, Gazetted Rules, 2014 Notified vide No. /DA/FAS/E-67/10/PT-I(A) dated 14th July, 2014, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the posts of Finance and Accounts Officer/ Treasury Officer, Group 'A' Gazetted, Non-Ministerial Rules, 2025 in the Department of Finance, Planning and Investment under the Government of Arunachal Pradesh, namely:-

1. **Short title and commencement:** (1) These rules may be called the **Recruitment to the posts of Finance and Accounts Officer/Treasury Officer Rules, 2025.**
- (2) They shall come into force from the date of their publication in the Arunachal Pradesh Gazette.
2. These rules shall apply to the posts as specified in column 1 of the schedule annexed to these Rules.

3. **Number of posts, classification and Pay Matrix:** The number of posts, their classifications and the Pay Matrix attached thereto shall be specified in columns 2 to 4 in the Schedule aforesaid.
4. **Method of recruitment, age limit and other qualifications etc. :** The method of recruitment to the said post, age limit, educational qualifications and other matters relating thereto, shall be as specified in columns 5 to 13 of the schedule aforesaid.
5. **Disqualification:** No person

(a) who has entered into or contracted marriage with a person having spouse living ; or

(b) who having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of these rules.
6. **Power to Relax:** While the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and in consultation with the Commission relax any of the provisions of these Rules with respect to any class or category of persons.
7. **Repeal and Savings:** The Arunachal Pradesh Finance and Accounts Officer/Treasury Officer (Group A) (Gazetted) (Entry Grade) Recruitment Rules, 2014 is hereby repealed.

Notwithstanding any such repeal, all rules and procedures corresponding to these rules and procedures in force immediately before commencement of these rules shall be deemed to have been validly made or taken under corresponding provisions of these rules.

Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to be provided for the Arunachal Pradesh Scheduled Tribes and other special categories of person in accordance with the orders issued by the Government of Arunachal Pradesh from time to time.
