Accordingly, the National Bamboo Mission Project, which was earlier under the Ministry of Forest and Environment, Government of India, was transferred to Ministry of Agriculture and Farmer's Welfare, Government of India.

Further, vide letter D.O. No. 15-01/2017-CC, dated 7th May, 2018, the Ministry of Agriculture and Farmer's Welfare, Government of India has directed the State Government to designate the Nodal Department for anchoring the mission in the State and nominate the Mission Director (MD), State Bamboo Development Agency (SBDA).

The matter was reviewed by the Agriculture Production Commissioner on 1st May, 2025 wherein representative from the Department of Agriculture and Department of Forest and Environment were present.

Accordingly, with the approval of the competent authority, The State Bamboo Mission is hereby transferred and placed under the Department of Agriculture.

1. The Election is to be held to elect **25 (Twenty-five)** Members to the Bar Council of Assam, Nagaland, Mizoram, Arunachal Pradesh and Sikkim in terms of Section 3(2)(b) of the Advocates Act, 1961.
2. The direction by the Hon'ble Supreme Court vide Order dated 08.12.2025 in W.P.(C) No. 581 of 2024 mandates women's representation to the extent of **thirty percent of the total seats**, out of which twenty percent shall be filled through election and ten percent shall be filled through co-option. Hence for a Council of total strength 25, the women's component may be reflected as 7 seats, of which 5 seats are to be filled up through election and 2 seat through co-option by the Bar Council of India. **The election hereby is notified for 23 seats** and within those 23 seats, a women elected component of 5 seats as per the direction by the Hon'ble Supreme Court vide Order dated 08.12.2025 in W.P. (C) No. 581 of 2024.
3. Publication of the provisional electoral rolls (after or pending verification) will be made on **06.03.2026**.
4. Inviting of objections to the electoral rolls will be accepted from **07.03.2026 to 13.03.2026**.
5. Publication of the final electoral rolls will be on **20.03.2026**.
6. Filling of Nomination Papers from **21.03.2026 to 27.03.2026**.
7. The Scrutiny of Nomination Papers from **28.03.2026 to 29.03.2026**.
8. Publication of list of candidates on **30.03.2026**.
9. Withdrawal of the candidature will be accepted up to **3.00 PM of 02.04.2026** from **31.03.2026**, to be followed by publication of the final list of candidates on the **same day** i.e. on **02.04.2026**.
10. Election as per preferential system of votes on **22.04.2026**.
11. Forms of Nomination Papers may be obtained from the office of the Council as well as from the office of all Bar Associations of Assam, Nagaland, Mizoram, Arunachal Pradesh and Sikkim from **16.03.2026**.
12. The Nomination Papers addressed to the Secretary proposed by 1 (one) Voter and seconded by another Voter (vide Rule 8 of the Bar Council Election Rules, 1968) may be delivered to the Secretary in the office of the Council from **11:00 A.M. to 4:00 P.M.** from **21.03.2026 to 27.03.2026**. Nomination paper for a candidate must be accompanied by a fee of **₹ 1,25,000 (Rupees One Lakh Twenty-Five Thousand)** only as per direction of the Bar Council of India vide letter No. BCi:D:6880/2025 (Council-STBCs) dated **25.09.2025**.
13. In the event of the election being contested, the poll will take place on **22.04.2026** between the hours from 10:00 A.M. to 4:30 P.M. and voting by personal ballot will be held at Guwahati, Amingaon, Abhayapuri, Barpeta, Bajali, Bijni, Bilasipara, Biswanath Chariali, Bongaigaon, Dhemaji, Dhubri, Dibrugarh, Diphu, Dimapur, Dhakuakhana, Goalpara, Golaghat, Gohpur, Gangtok, Hailakandi, Hojai, Hatsingimari, Haflong, Itanagar, Jorhat, Kaliabor, Kokrajhar, Kohima, Mangaldai, Margherita, Morigaon, Mizoram, Mokokchung, Nagaon, Nalbari, North Lakhimpur, Rangia, Sivasagar, Silchar, Sonari (Charadeo), Sribhumi, Tezpur, Tinsukia, Tezu and Udalguri.
