No. LAW (W) 94/2025/194.—In exercise of the powers conferred by sub-section (1) of Section 5 of the Industrial Relations Code, 2020 and in supersession of the Government's earlier notification No. LAB(W)46/99 dated 26th June, 2023, except as respects things done or omitted to be done before such supersession, the Governor of Arunachal Pradesh is pleased to appoint the following officers as Registrar, Additional Registrar, Joint Registrar and Deputy Registrars for the purpose of exercising powers and discharging functions under Section 5 of the Industrial Relations Code, 2020, within their respective jurisdiction as specified against each at column (4) of the table below :-
