PRELIMINARY NOTIFICATION

The 9th February, 2026

(Issued under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(11)/1/2026/430.— **WHEREAS**, the power and function of the appropriate authority under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the State.

WHEREAS, the Border Road Organization (BRO) has sent a requisition vide No. 2075/DPR/KLG/02/E2 dated 29th September, 2025 and No. 2075/DPR/KLG/01/E2 dated 29th September, 2025 for acquisition of land to an extent of 34.58 Hectare for Construction of National Highway Double Lane (NHDL) Koloriang to Sarli.

WHEREAS, It appears to the Governor of Arunachal Pradesh that the land is likely to be needed at the locality more fully described in the schedule below for a public purpose for an area measuring 34.58 Hectares located at Kurung Kumey District, Arunachal Pradesh. It is hereby notified that the land in the locality/localities in the schedule below is likely to be acquired for the above said purpose at expenses of the requiring body. **Further, the Deputy Commissioner, Kurung Kumey District, Koloriang vide his letter No. KKD/Klg-Sri/02/2025-26/2292 dated 29th December, 2025 and letter No. KKD/LM/NHDL/Klg-Sri/02/2025-26/3016 dated 28th January, 2026 has informed that the construction of Road NHSL Koloriang to Sarli KM 158.00 to KM 178.00 of area 34.58 Hectares will not cause involuntary human displacement/shifting, therefore there will be no adverse social impact as a result of acquisition of these lands and also the number of families likely to be resettled due to the proposed land acquisition is nil and as such publication of summary of the Rehabilitation and Resettlement scheme is not required.**

NOW THEREFORE, this notification is made under the provisions of Section-11(1) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said act.

Under Section-11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale/purchase/gift, specified in the preliminary notification or create any encumbrance on such land from the date of publication of this notification without prior approval of the Collector.

Any person interest in the said land and whomsoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Kurung Kumey District, Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office, Koloriang.
