## PRELIMINARY NOTIFICATION

The 12th February, 2026

### Issued Under Section -11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013

No. LMD-13011(13)/45/2025/497.—**WHEREAS**, the power and function of the appropriate authority under the right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the State.

**WHEREAS**, the Town Planning department of Urban Affairs has sent a requisition Vide No. TP-15/2024-DIR-TP/Town Planning (E-225831) /2007-11. dated Itanagar the 17th September, 2025 for acquisition of land to an extent of **26596.37 Sq Mtrs. for RCC Trapezoidal Drain Telephone Nallah** at Hollongi under Balijan Circle Papum Pare District.

**WHEREAS**, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below for RCC Trapezoidal Drain for Telephone Nallah for an area measuring **25096.35 Sq Mtrs.** located at Hollongi District Papum Pare Arunachal Pradesh. It is hereby notified that land in the locality/localities in the schedule below is likely to be acquired for the above said purpose at expense of requiring body. The summary of the social impact assessment for the locality/localities may be exempted as there is no any displacement of family/families.

**NOW THEREFORE**, this notification is made under the provisions of Section -11(1) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engaged for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section -11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e sale/purchase/ gift, specified in the preliminary or create any encumbrance on such land from the date of publication of this notification without prior approval of the Collector.

Any person interest in the said land and whomsoever has any objection to the acquisition of the said land, any within 30 ( thirty) days from the date of publication on this notification provided under Section - 15 of the Act, file such objection in writing before the Deputy Commissioner Papum Pare District, Yupia, Arunachal Pradesh.

The plan of the land may be inspected at Land Management Branch, DC's office Yupia.
