DECLARATION

The 17th February, 2026

(Under Section (19) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/43/2025/577.—**WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total **0.826** Hectare (**8260 sqmtr**) of land is required at **Noglo** Villages under **Lazu** Circle, **Tirap** District for public purposes namely **Construction/establishment of Free Movement Regime (FMR)** crossing point near Border Pillar at Noglo, District Tirap along the Indo-Myanmar border by the 44-Assam Rifle PIN-932044 C/o 99 APO.

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide memo **No. LMD-13011/43/2025/69** dated **12th December, 2025** notifying that intention of the State Government for acquiring of **0.826** Hectare (**8260 sqmtr**) of the land and inviting public claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Tirap District, Vide his memo **No. KSA/LR/IMB/CRSNG-PNT/2024-25** dated **3rd November, 2025** certified that land is a private land and is free from public and Government projects and that there are no project affected families and therefore no compensation towards rehabilitation and resettlement of **Lazu to Indo-Myanmar** Tri-junction are required to be paid under Section 31 of the LARR Act and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters-II and III and Section-15 and 16 shall not apply to acquisition process in respect of the said land at **Lazu** to Indo-Myanmar Tri-junction for **Construction/Establishment of Free Movement Regime (FMR)** Crossing point near Border Pillar at Noglo, Distrip Tirap.

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the declaration under Section 19 of the Act Specifying that the piece of land measuring **0.826** Hectare (**8260 sqmtr**) located at **Noglo** Villages under **Lazu** Circle, **Tirap** District is being acquired, the detailed description whereof is as follows :
