## PRELIMINARY NOTIFICATION

The 8th January, 2026

(Under Section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(11)/25/2025/209.—**WHEREAS**, the power and function of the appropriate authority under the Right to Fair Compensation and Transparency in LARR Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the State.

**WHEREAS**, the requiring body 120 RCC (BRTF) has sent a requisition vide No. Nil dated Nil for acquisition of land to an extent of 288180.00Sqm (274080.00 Sqm for Road,3600.00 Sqm for Helipad and 10500.00 Sqm for Muck Disposal Area) for construction of Lungur-Do Mane- Talung La BRTF Road in Mago Village under Thingbu Circle in Tawang District.

**WHEREAS**, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below for Lungur- Do Mane-Talung La BRTF Road in Mago Village under Thingbu Circle for an area measuring 288180.00 Sqm for C/o Lungur-Do Mane Talung La BRTF Road, Helipad and Muck Disposal Area in Mago Village Thingbu Circle in Tawang District. It is hereby notified that land in the locality/ localities in the schedule below is likely to be acquired for the above said purpose at expenses of requiring body. **Further, the Deputy Commissioner, Tawang District, Tawang vide his letter No.TLR-70/2013-14 dated 10th November, 2025 has informed that vide letter No. 236/L-D-T/82/E2 dated 1st October, 2025, the requiring agency OC, 120 RCC, C/o 99 APO has submitted a certificate stating that there will be no involuntary displacement of human settlement / habitation involved due to acquisition of land for construction of Lungur -Do Mane Talung La BRTF road in Mago Village under Thingbu circle in Tawang District.**

**NOW THEREFORE**, this notification is made under the provisions of Section 11(1) of LARR Act, 2013 and to all whom it so ever may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section 11(1) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the collector.

Any person interest in the said land and whosoever has any objection to the acquisition of the said land, may within 30 (Thirty) days from the date of publication of this notification provided under Section 15 of the Act, file such objection in writing before the Deputy Commissioner, Tawang District, Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office, Tawang.
