Terms and Conditions :

1. The service of the appointees will be governed by the CCS (Temporary Service Rules) 1965 as amended upto date and liable to be terminated by the Government by serving one month's notice from either side.

1. **Planning and Design** : Preparation of Detailed Project Reports (DPRs), technical designs and bid documents.
2. **Execution and Management** : Undertake execution of all civil and technical works entrusted by SJETA, ensuring compliance with approved specifications, timelines and quality standards.

3. **Procurement** : Inviting tenders (e-procurement), awarding contracts and managing procurement processes for the project.
4. **Quality Control** : Ensuring 2nd tier independent quality monitoring and completion of works within the specified timeline.
5. **Financial Management** : Ensuring effective management of funds, processing and verification of invoices and effecting payments in accordance with SNA-SPARSH guidelines. Utilization Certificates (UCs) shall be submitted to the Finance Department/Funding Agency in a timely manner.
6. **Command Area and Coverage** : The WRD shall cover all the designated areas under the project, including command area development, minor irrigation projects and flood protection works, to enhance irrigation efficiency.
7. **Coordination** : All other departments, including Agriculture, Rural Development and District Administration, shall cooperate with the WRD in matters related to land acquisition, Rehabilitation and Water Management.
8. **Funding** : The funding for the project will be channeled through the WRD as a Nodal Agency as per the administrative sanction accorded under (Scheme/Funding Source, e.g., NABARD-RIDF/NDB).
