No. 1/1(i)/2026-E.II (B) —The undersigned is directed to refer to this Department's Office Memorandum No. 1/4(i)/2025-E.II (B) dated 6th October, 2025 on the subject mentioned above and to say that the President is pleased to decide that the rates of Dearness Allowance payable to Central Government employees, shall be enhanced from **58% to 60% of the Basic Pay with effect from 1st January, 2026.**

2. The term 'Basic Pay' in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix as per 7th CPC recommendations accepted by the Government, but does not include any other type of pay like special pay etc.
3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).
4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.
5. These orders shall also apply to the civilian employees paid from the Defence Services Estimates and the expenditure will be chargeable to the relevant head of the Defence Services Estimates. In respect of Armed Forces personnel and Railway employees, separate orders will be issued by the Ministry of Defence and Ministry of Railways respectively.

The term Basic Pay in the revised pay structure means the pay drawn in the prescribed level in the Pay Matrix as per 7th CPC recommendations accepted by the Government, but does not include any other type of Pay like special pay etc.

The Dearness Allowance will continue to be a district element of remuneration and will not be treated as pay within the ambit of FR. 9 (21).

The expenditure on account of this Dearness Allowance shall be met from existing Budget provisions of the Department concerned in the Current Financial year 2026-2027.

The revised rates of Dearness Allowance shall be applicable to regular State Government employees only and shall not apply to private/Non-Governmental institutions receiving Grants-in-Aid from the State Government.
