PRELIMINARY NOTIFICATION

The 19th May, 2026

(Issued under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/11/10/2026.— **WHEREAS**, the Power and function of the appropriate authority under the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercise and discharged by him within the State.

WHEREAS, the Defence Estate Officer, Itanagar has sent a requisition vide No. DEO/JOR/AC/100/ACQ/VOL-I/115 dated 22nd April, 2026 for acquisition of land measuring area 7.16 Acres (28,975.489 Sqm) for establishment defence unit.

WHEREAS, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below for establishment of defence unit at measuring area 7.16 acres (28,975.489 Sqm) at Maro under Maro Circle in Upper Subansiri District. It is hereby notified that land in the locality in the schedule below is likely to be acquired for the above said purpose at expense of requiring body. **Further, the Deputy Commissioner, Upper Subansiri District, Daporijo has intimated vide letter No. LM/DRJ-83(B)/2018-19/114 dated 8th May, 2026, that it is certify that land is a private land and free from public and Government projects and there is no project affected families and no compensation to wards Rehabilitation and Resettlement.**

NOW THEREFORE, this notification is made under the provision of Section -11(1) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section-11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., Sale/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the Collector.

Any person interest in the said land and whomsoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Upper Subansiri District, Daporijo, Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office, Daporijo.
