NOTIFICATION

The 19th May, 2026

No. DOI-13014/22/2026/3057-63.— Partial modification of Chapter 1 ‘Objectives” of Arunachal Pradesh Industrial Development Investment Policy, 2025, that State Government hereby notifies the following provisions :

1. The State Government shall consider unlocking vacant or under-utilised land in existing industrial clusters by reassessing and liberalising the Industrial Area Allotment norms to ensure land parcel flexibility, land-use flexibility and flexibility to sub-lease, transfer or re-assign industrial plots. In order tp provide a viable exit route to industrial units, flexibility shall be allowed for sub-leasing or re-assignment of plots, including transfer to joint ventures or subsidiaries, subject to prescribed conditions.
2. Flexible development norms are permitted within industrial areas, including higher FAR, reduced setbacks, increased ground coverage, allowance on smaller plots, common parking and relaxation of height restrictions, along with concessional land-use conversion rates and targeted waivers of duties and fees, to lower operational costs and encourage growth, particularly for MSMEs. Additionally, State Government shall consider allowing EWS or local-cost housing within industrial areas and promote the ‘walk-to-work’ concept, including housing for potential workers.
3. Adoption of the Public Private Partnership (PPP) model for provision of state-of-the-art infrastructure and services shall be permitted within industrial areas for the following facilities:

• Common Effluent Treatment Plants (CETP)/ETP/STP

• Solid and hazardous waste management facilities

• Fire stations, fire safety systems and emergency response facilities.

• Power distribution systems, substations, renewable energy infrastructure

• Water supply, recycling and utility networks

- Workers, welfare facilities including housing, hostels, creches, health centres
- Skill development centres, training institutes
- Logistics, warehousing, truck terminals and parking facilities.
- Estate management services including security, landscaping and maintenance etc.
- Any other projects as decided by the State Government from time to time.

4. The State Government shall consider providing adequate fire safety mechanisms in industrial areas, including public fire hydrants and other common facilities such as effluent treatment plants, worker safety and welfare amenities and creche facilities. One-time or periodic user charges from industrial units towards provision and maintenance of such common facilities shall be applied.

5. The State Government shall also permit industrial units located outside industrial areas to pool resources to meet compliance requirements relating to worker safety, worker welfare, fire safety, effluent treatment and other statutory obligations, subject to prescribed conditions.

6. This Notification shall come into force with immediate effect and shall be read as an Addendum to the State Industrial Policy.

7. No procurement of new Government vehicles shall be made except for emergency service requirement vehicles.
8. Air-conditioner temperature settings in Government offices and establishments shall be maintained at 24° C or above to optimize electricity consumption.
9. Minimum use of edible oil shall be encouraged in Government Schools, Colleges, Hospitals, Hostels and Government-run canteens.
10. Certified organic and natural farming practices shall be promoted across the agriculture and horticulture sectors.
11. All Electronics items procured by Government Department and Offices shall be 5-star energy efficiency rated.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- Power to relax:** Where the Governor of Arunachal Pradesh is of the opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and in consultation with the Selection Board/Arunachal Pradesh Public Service Commission/Department of Administrative Reforms relax any of the provisions of these rules with respect to any class or category of person.
- Repeal and saving:** All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these rules.

Nothing in these rules shall affect reservation/ relaxation of age limit and other concessions required to provide for the Arunachal Pradesh Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.
