- (e) No approval or permission shall be granted for change from agricultural or allied (including horticultural) purpose to any other purpose “except in areas where the Master Plan has been notified.
4. In the principal rules 50, Form-7 shall be revised to incorporate updated land use classification, including conversion from agricultural to other uses or mixed use, along with post-conversion status, ownership details and mutation entries”.
