PRELIMINARY NOTIFICATION

The 18th June, 2026

(Issued under Section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/14/11/2025/608.—**WHEREAS**, the power and functions of the appropriate authority under the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the State.

WHEREAS, the Manager, Arunachal Pradesh Comprehensive Scheme, Power Grid Daporijo has sent a requisition vide No. NER/APCOMP/Daporijo /502/1139 dated 28th April, 2026 for acquisition of land to an extent of 2028.00 Sqm approach Road to connect 33/11 KV Maro Sub-Division.

WHEREAS, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below for construction approach Road to connect 33/11 KV Maro Sub- Station net length 169.00 m length x12.00m breadth =2028.00 Sqm under Maro Circle in Upper Subansiri District, Arunachal Pradesh. It is hereby notified that land in the locality in the schedule below is likely to be acquired for the above said purpose at expense of requiring body. **Further, the Deputy Commissioner, Upper Subansiri District, Daporijo vide his letter No. LM/DRJ-66/2015(P-IV)/228 dated 15th June, 2026 has certified that the land proposed for construction of approach Road to connect 33/11 KV Maro Sub- Station under Maro Circle in Upper Subansiri District is a private land and free from Public and Government projects and there is no project affected families.**

NOW THEREFORE, this notification is made under the provision of Section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concerned.

The Governor of Arunachal Pradesh hereby authorizes the officers and officials for the time being engaged for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provisions of Section-12 of the above said Act.

Under Section -11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the Collector.

Any person interested in the said land and whosoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification as provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Upper Subansiri District, Daporijo, Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office, Daporijo.
