DECLARATION

The 19th May, 2026

(Under Section (19) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/34/2025/288.— **WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total of **0.60 Hectares (6000 Sqmtrs)** of land is required at **Sape Villages** under Polosang Circle of Kurung Kumey District for public purposes namely:- **Establishment of New Dett. of BRO, 85RCC in the State of Arunachal Pradesh (Polosang Circle Kurung Kumey District).**

WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. LMD-13011/34/2025/62 dated Itanagar, the 12th December, 2025 notifying the intention of the State Government for acquiring of **0.60 Hectares (6000 Sqmtrs)** of the said land and inviting public claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Kurung Kumey District, vide his Memo No. KKD/LM/85RCC(GREFF)/2024-25/2286 dated the Koloriang on 28th November, 2025 certified that land is a private land and free from public and Government projects and that there are no project affected families and therefore no compensation towards Rehabilitation and Resettlement of Sape Village under Polosang Circle of Kurung Kumey District are required to be paid under Section 31 of the LARR Act and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters-II and III and Section 15 and 16 shall not apply to acquisition process in respect of the said land at Sape Village under Polosang Circle of Kurung Kumey District for Establishment of New Dett. of BRO, 85 RCC in the State of Arunachal Pradesh (Polosang Circle Kurung Kumey District).

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring **0.60 Hectares (6000 Sqmtrs)** located at Sape Village under Polosang Circle of Kurung Kumey District is being acquired, the detailed description whereof is as follows:-
