NOTIFICATION

The 10th July, 2026

(Issued Under Section (10) of the Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amemdment Act, 2024)

No. LMD-13011(11)/24/2026/790.— **WHEAREAS**, the powers and functions of the appropriate authority under Section 10 of Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amendment) Act, 2024 vested in the Governor of Arunachal Pradesh the power of to be exercised and discharged by him for acquisition of land for public purpose within the State.

AND WHEREAS, the Governor of Arunachal Pradesh is satisfied that the land measuring 1.478 Acres (5981.57 sqm) mentioned in the schedule below is needed for public purposes, namely for establishment of **Border Outpost (BOP) by 61 Bn SSB at Samphung Village under Kalaktang Circle, West Kameng District, Arunachal Pradesh.**

AND WHEREAS, under Section 10 of Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amendment) Act, 2024, Government may acquire any Jhum Land required for public purpose by giving an opportunity to those having rights in the land and after payment of a reasonable compensation so determined by the Government which shall not be less than the amount computed under the provisions of extant law i.e the Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013 for the being in force.

NOW, THEREFORE, the Governor of Arunachal Pradesh do hereby declare that the land described in the schedule below is hereby notified for the above mentioned purpose under Section 10 of Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amentdment) Act, 2024 for the establishment of **Border Outpost (BOP) by 61 Bn SSB at Samphung Village under kalaktang Circle, West Kameng District, Arunachal Pradesh.**

Any person (s) who has any objection to the acquisiton of the said land for the said purpose may file such objection in writing to the office of the Deputy Commissioner, West Kameng District within 30 (thirty) days from the date of publication of this notification, clearly stating the reason (s) for such objections and the Deputy Commissioner, in his capacity shall dispose off the same after giving reasonable opportunity of being heard to extinguish the claim of land owners.

The Deputy Commissioner, West Kameng district, Bomdila shall possession of the above mentioned land for the said purpose after tendering payment of compensation to land owner/person interested.

The map and plan may be inspected in the office of the District Land Revenue and Settlement Officer, West Kameng District, Bomdila during office hours.
