PRELIMINARY NOTIFICATION

The 19th May, 2026

(Issued under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(12)/2/2026/296.—**WHEREAS**, the powers and function of the appropriate authority under the Right to Fair Compensation and Transparency in LARR Act 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the state.

WHEREAS, the requiring 38th BN SSB has sent a requisition letter vide No. Nil dated 19th November, 2025 for acquisition of land to an extent of 12140.00 Sqm (1.2140 Ha) for establishment of SSB BoP at Ningsangla (Ngorngam) in Mukto Village under Mukto Circle in Tawang District.

WHEREAS, it appears to the Governor of Arunachal Pradesh that lands are likely to be needed at the locality more fully described in the schedule below for establishment of SSB BoP for an area measuring 12140.00 Sqm (1.2140 Ha) located at Ningsangla (Ngorngam) in Mukto Village under Mukto Circle in Tawang District, Arunachal Pradesh. It is hereby notified that land in the locality/localities in the schedule below is likely to be acquired for the above said purpose at expenses of requiring body. Furthermore, Deputy Commissioner, Tawang on the basis of the letter received from the Commandant, 38th Bn SSB vide letter No. VIII-24/Pnr/Land-Ningsangla/38th BN/SSB/TWG/2009-10/2543 dated 23rd March, 2026 has informed that the number of families likely to be resettled due to the proposed land acquisition is nil and as such, publication of summary of the Rehabilitation and Resettlement scheme is not required.

NOW THEREFORE, this notification is made under the provisions of Section 11(1) of LARR Act, 2013 and to all whom it so ever may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and Officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section 11(1) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the collector.

Any person interest in the said land and whosever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section 15 of the Act, file such objection in writing before the Deputy Commissioner, Tawang District, Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office, Tawang.
