DECLARATION

The 20th May, 2026

(Under Section (19) of the Right to Fair Compensation and Transparency
in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(13)/45/2025/305.—**WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total **3.3703 Ha (33703.38 Sqmtrs.)** of Land is required at Hollongi Village under Balijan Circle Papum Pare District for public purpose namely for construction of RCC Trapezoidal Drain.

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide No. **LMD-13011(13)/45/2025/497** dated **12th February, 2026** notifying the intention of the State Government for acquiring the said land and inviting public claims and objection to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Papum Pare District, vide No. **DLRSO/PP/GOVT/TLPN-151/2025 dated yupia the 24th February, 2026** certified that land is a private land and free from public and Government projects and that there is no project affected families and therefore no compensation towards Rehabilitation and Resettlement are required to be paid under Section 31 of the LARR Act and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters - II and III and Section - 15 and 16 shall not apply to the acquisition process in respect of the said and for the above project.

AND NOW therefore, the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring **3.3703 Hectares (33703.38 Sqmtrs)** located at Hollongi Village under Balijan Circle, Papum Pare District is being acquired for the said purpose, the detailed description whereof is as follows :-
