PRELIMINARY NOTIFICATION

(U/S 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(11)/12/2026/423.— **WHEREAS**, the power and function of the appropriate authority under the Right to Fair Compensation and Transparency in LARR Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the state.

WHEREAS, the requiring body 55th Bn ITBP (Name of the requiring body) has sent a requisition vide No. ITBP/55th BN/Engr/Land/57/2026 Dated 13th March, 2026 for acquisition of land to an extent of land measuring 16188.00 Sqm at Growlethang and 9915.00 Sqm at Kyapho in Shocktsen village area and 6072.00 Sqm at Khinzamane and 5915.00 Sqm at Bhavani in Lumpo village area for establishment of ITBP BoP in Shocktseng village area, Khinzamne and Bhavani in Lumpo village area under Jemeithang circle in Tawang District.

WHEREAS, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below establishment of ITBP BoP at Growlethang and Kyapho in Shocktseng village area, Khinzamne and Bhavani in Lumpo village area under Jemeithang circle in Tawang District. It is hereby notified that land in the locality/ localities in the schedule below is likely to be acquired for the above said purpose at expenses of requiring body. The Summary of the social impact assessment for the locality/ localities described in the mentioned scheduled is also included below for mentioned purpose.

NOW THEREFORE, this notification is made under the provisions of Section 11 (1) of LARR Act 2013 and to all whom it so ever may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section 11(1) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/ purchase/ gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the collector.

Any person interest in the said land and whosoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Tawang district, Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office, Tawang.
