DECLARATION

The 23rd October, 2025

(Under Section(19) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No.LMD-13011/64/2024/1780.— **WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total of 16007.00 Sqm of land belonging to Bongleng Village in Bongkhar Circle, Tawang District for public purposes namely for establishment of SSB BoP.

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act. 2013 was issued by the Department of Land Management vide Memo No.LMD-13011/64/2024/1644 dated 10th December, 2024 notifying the intention of the State Government for acquiring of 16007.00 Sqm of land for **SSB BoP at Bongleng** and inviting claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Tawang District, Tawang vide his Memo No.TLM-134/2013 (Vol-I) 5549 dated 22nd October, 2024 certified that the land is a community land and free from public and Government projects and that there is no project affected families and therefore no compensation towards Rehabilitation and Resettlement are required to be paid under Section 31 of the LARR Act, 2013 and has requested that State Government to issue the declaration under Section 19 of LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that chapters-II and III and Section-15 and 16 shall not apply to acquisition process in respect of the said land Bongleng for establishment of SSB BoP.

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring 16007.00 Sqm located at Bongleng in Bongkhar Circle, Tawang District is being acquired and the detailed description whereof is as follows : -
