PRELIMINARY NOTIFICATION

The 8th June, 2026

(Issued under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(11)/13/2026/466.—**WHEREAS**, the power and functions of the appropriate authority under the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the state.

WHEREAS, the Requiring Body, the Commandant, 30 Bn. SSB, Dirang, West Kameng District Arunachal Pradesh has sent a requisition vide letter No. XI/30 Bn/Ops/BOP/KLP/Corresp/2021/9898 dated 8th June, 2023 and No. IX/548/30th Bn./SSB/PNR/Misc/Corresp/25/18034-37 dated 14th August 2025, for acquisition of land to an extent of (1) 16162.07 Sq. Mtrs. for Establishment of SSB BOP at Nache GG in Tsergyap area of Sange Village and (2) 15277.92 Sq. Mtrs. for establishment of SSB BOP at Bralle GG in Sangthonsa area of Nyukmadung Village, under Dirang Sub-Division, West Kameng District.

WHEREAS, it appears to the Governor of Arunachal Pradesh that the land is likely to be needed at the locality more fully described in the schedule below for establishment of SSB BOP for an area of 16162.07 Sq. Mtrs., located at Nache GG in Tsergyap area of Sange Village and SSB BOP for an area measuring 15277.92 Sq. Mtrs., located at Bralle GG in Sangthonsa area of Nyukmadung Village under Dirang Sub-Division, West Kameng District, Arunachal Pradesh. It is hereby notified that land in the locality/localities in the schedule below is likely to be acquired for the above said purpose at expense of requiring body. **Further, the Deputy Commissioner, West Kameng District, Bomdila vide letter No. WK/LM-74/2025 dated 29th April 2026 has certified that there is no involuntary human displacement due to the proposed acquisition of land for the establishment of SSB BOPS under Dirang sub-division of West Kameng District and hence has requested for exemption from SIA for the said projects.**

NOW THEREFORE, this notification is made under the provisions of Section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resttlement Act, 2013 and to all whom it may concern.

The Government of Arunachal Pradesh is hereby also authorizes the officers and officials for the time being engage for the purpose with their staff and workman to enter upon page 1 of 3 and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section 11 (4) of the Act.no person shall make any transaction or cause any transation of land i.e. sales/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the Collector.

Any person interest in the said land and whosoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, West Kameng District, Bomdila, Arunachal Pradesh.

The plan of the land my be inspected in the Land Management Branch , DC’s Office Bomdila, West Kameng District Arunachal Pradesh.
