DECLARATION

The 17th June, 2026

(Under Section (19) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No.LMD-13011/24/2025/574.—**WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total 56.690 Hectares (5,66,900 Sqm.) of land is required at Kibitho, Kundao, Pallang and Glothong Villages jurisdiction, Kibitho and Goiliang Circle, Hawai and Hayuliang Sub Division, Anjaw District for public purpose, namely construction of Kibitho-Kundao Road from km 0.00 to km 19.557 kms Part-II to NHSL specification under Anjaw District, by the 116, Road Construction Coy, (GREF).

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. LMD. 13011/24/2025/1154 dated Itanagar the 20th August, 2025 notifying the intention of the State Government for acquiring of 56.690 Hectares (5,66,900 Sqm.) of the said land and inviting public claims & objections to the proposed acquisition of land, if any.

AND WHEREAS, the Deputy Commissioner, Anjaw District, vide his Letter No. AN/LM-17/2024-25/6480-84 dated Hawai the 4th September, 2025 certified that land is a private land and free from public and Government projects and that there are no project affected families and therefore no compensation towards rehabilitation and resettlement and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters-II and III and Section-15 & 16 shall not apply to acquisition process in respect of the said land 56.690 Hectares (5,66,900 Sqm.).

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring 56.690 Hectares (5,66,900 Sqm.) located at Kibithu, Kundao and Glothong, Pallang villages jurisdiction, Kibitho and Goiliang Circle, Hawai and Hayuliang Sub Division, Anjaw District respectively is being acquired, the detailed description whereof is as follows :-
