PRELIMINARY NOTIFICATION

The 28th July, 2026

(ISSUED UNDER SECTION 11(1) OF THE RIGHT TO FAIR COMPENSATION AND TRANSPARENCY
IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013)

No. LMD-13011/31/2025/896.—**WHEREAS**, the power and functions of the appropriate authority under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the state.

WHEREAS, the Requiring Body, the Officer Commanding, 97 Road Construction Company (GREF), C/O 99 APO, has sent a requisition Vide No. 267/DPR/ND-NGG/20-30/48/E2 dated 17th May, 2025, for acquisition of land to an extent of 14.94 Hectres (144980 Sq. Mtrs.) for construction of Mandala-Debrabu-Naga GG road between KM 20.00 to KM 39.00 (New Ch.39.340 to 106.660) Net length of 13.320 KM from CI-9 to NHDL specification under Dirang Sub-Division, West Kameng District.

WHEREAS, it appears to the Governor of Arunachal Pradesh that lands are likely to be needed at the locality more fully described in the schedule below for construction of Mandala-Debraru-Naga GG between KM 20.00 to 39.00 (New Ch. 93.340 to 106.660) net length of 13.320 KM from CI-9 to NHDL specification under Dirang Sub-Division, West Kameng District. Further, the competent authorities have recommended the proposal informing that there will be no involuntary displacement as a result of acquisition by GREF and as such SIA is not required and publication of summary of the Rehabilitation scheme is not required.

NOW THEREFORE, this notification is made under the provisions of Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever may concern.

The Government is pleased to authorize DC, West Kameng, Officer Commanding, 97 RCC (GREF) and their staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in Section 12 of the said Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase etc. or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

Any person interested in the said land and whosever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification as provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, West Kameng District, Bomdila, Arunachal Pradesh.

The plan of the land may be inspected in the office of the Collector and DLRSO on any working day during the working hours.
