PRELIMINARY NOTIFICATION

The 29th July, 2026

(Issued Under Section 11(1) of the Right to Fair Compensation and Transparency in Land, Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(11)/25/2026/935.---WHEREAS, the power and function of the appropriate authority under the Right to Fair Compensation and Transparency in LARR Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the state.

WHEREAS, the requiring body ITBP has sent a requisition letter for Bumla & Topokhar vide No. Bumla & Topokhar land, 4th Bn ITBP/2025-550-55 dated 12th September, 2025 for acquisition of a land measuring **16187.00 Sqm at Bumla and 16180.00 Sqm at Topokhar** for establishment of **ITBP BoP**.

WHEREAS, it appears to the Governor of Arunachal Pradesh that these lands are likely to be needed at the locality more fully described in the scheduled below for **establishment of ITBP BoP** for an area measuring **16187.00 Sqm**. located at Bumla under Tawang circle and **16180.00 Sqm** at "Topokhar under Thingbu circle in Tawang district, Arunachal Pradesh. It is hereby notified that land in the locality/ localities in the schedule below is likely to be acquired for the above purpose at the expenses of requiring body. Further, it has been stated by competent authority that there will be no adverse social impact as a result of acquisition of this land by ITBP and also the number of families likely to be resettled due to the proposed land acquisition is nil and as such publication of summary the Rehabilitation and Resettlement Scheme is not required.

NOW THEREFORE, this notification is made under the provisions of Section 11(1) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whom it so ever may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase/ gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the collector.

Any person interest in the said land and whosoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Tawang district, Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office, Tawang.
