Whereas he shall be authorized to co-ordinate, submit proposal and to attain any Meeting/Summit/ Conclave with any organization, Agencies, at regional, national and international level. In case of international program, proper permission shall be obtained from concerned authority.

Now therefore the Governor of Arunachal Pradesh is pleased to appoint Shri Oli Koyu, DNC, SSP, and SJMFC (NDPS) as State Special Nodal Officer and advisor for SCSR and Investment on all Narcotics related/matter to Government and shall also be Special Nodal Officer-cum Advisor to all link/stock holder Department of Narcotics (or officiating) or ex-officio at the rank of Additional Narcotic Commissioner (CBN) and Pay Level 14, (in the Pay Grade of ₹ 10,000 and Pay Band at ₹ 37,400-67,400). i.e. Home, Allied Industry, Tourism, Forest and Environment, Rural Development and Panchayati Raj, Veterinary, Planning and Investment and Finance, Agriculture, Horticulture, Fishery, Animal Husbandry and Dairy, Sericulture, Health and Family welfare, Woman and Child Development, Human Right Commission, Arunachal Pradesh protection of Child Right, Arunachal Pradesh women Commission, (Government of Arunachal Pradesh) APEDA-(Power), Education, Social Justice and Empowerment and Tribal Affairs (SJETA) and Sports and Youth Affairs Department along with all other link departments under NCORD as per the MHA Government of India.

This order shall stand valid for the period of 20 years on the basis of Mission Mode Program for drugs free State of Arunachal Pradesh. He shall be reporting to Chief Secretary, Principal Secretary Home and Secretary Tax, Excise and Narcotics as in his appointment order. He shall perform above duty/job at the capacity of DNC (N) not as an SNO (N) as he is being appointed for above ex-officio post against the regular post of DNC(N)/SR and RO(N).
