NOTIFICATION

The 28th July, 2026

No. HOME-11015(12)/7/2024.—In pursuance of the approval accorded by the Hon'ble State Cabinet in its 6th (Sixth) Meeting held on 14th May, 2026 under Agenda Item No. 7, on a proposal processed in consultation with the Department of Health and Family Welfare, Government of Arunachal Pradesh and with the concurrence of the Finance, Planning and Investment Department conveyed vide its noting dated 20th July, 2026, the Governor of Arunachal Pradesh is pleased to order the merger of the lone sanctioned post of Compounder under the Home Department, presently attached to the Police Training Centre (PTC), Banderdewa, with the post of Compounder, re-designated as Pharmacist, under the Directorate of Health Services, Department of Health and Family Welfare, Government of Arunachal Pradesh.

Consequent upon the aforesaid merger, the incumbent holding the merged post shall stand absorbed into the Pharmacist cadre under the Directorate of Health Services, Department of Health and Family Welfare, Government of Arunachal Pradesh and the merged post shall thereafter be borne on the strength of the said cadre. The post shall cease to exist as a separate post under the Home Department.

The sanctioned strength of the Home Department shall stand reduced by One (01) post of Compounder and the sanctioned strength of the Directorate of Health Services, Department of Health and Family Welfare shall stand correspondingly increased by One (01) post of Pharmacist, without creation of any additional post or involving any increase in the overall sanctioned strength of the Government.

The administrative control, establishment matters, seniority, promotion, transfer, leave, disciplinary proceedings and all other service matters relating to the merged post and the incumbent shall thereafter vest with the Department of Health and Family Welfare and shall be governed by the Recruitment Rules and other Government orders/instructions applicable to the cadre of Pharmacists.

The service rendered by the incumbent against the post of Compounder under the Home Department prior to the issuance of this Notification shall be treated as qualifying and continuous service for all service-related purposes, subject to the applicable Recruitment Rules and Government orders.

The incumbent shall be allowed notional pay fixation in the applicable Pay Level of Pharmacist under the 7th Central Pay Commission with effect from 1st January, 2016. However, the actual financial benefits arising out of the merger, re-designation and consequential pay fixation shall accrue only with effect from 14th May, 2026, being the date of approval of the proposal by the Hon'ble State Cabinet and no arrears of pay and allowances shall be admissible for any period prior thereto, in accordance with the concurrence of the Finance, Planning and Investment Department.

The Director General of Police, Arunachal Pradesh, the Director of Health Services, the Principal, Police Training Centre, Banderdewa and all other authorities concerned shall take immediate consequential action for implementation of this Notification, including transfer of the post, updation of establishment records, transfer of service records, pay fixation, entries in the Service Book and all other consequential administrative actions required to give effect to this Notification.

This Notification shall come into force with immediate effect.
