The State Advisory Board on Minimum Wages shall co-ordinate the work of sub-committee appointed under Section 42(5) of the Code on Wages, 2019 and to advise the government in the matter of fixing and revising minimum rate of wages payable to the workers under schedule employment.

The official members of the State Minimum Wages Advisory Board shall draw TA/DA from their respective Department/Organization for attending Board meeting/sitting as may be applicable and as per their entitlement. The non-official members shall draw their TA/DA as admissible to Group- 'A' Officer of the lowest rank from the Labour and Employment Department as may be applicable.

The terms of the office of the official and non-official members of the Board shall be 5 (five) years from the date of issue of this notification, provided that such members notwithstanding the expiry of two years will continue to hold office until the successors are nominated/appointed.
