No.LLJ-12011(11)/1/2026(E-283464).— In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to amend the Junior Librarian (Law) Recruitment Rules, 2020 as follows,-

- Short title and commencement:** (i) These rules may be called the Junior Librarian Recruitment (Amendment) Rules, 2026.
(ii) It shall be deemed to have come into force with effect from 23rd January, 2020.
- Amendment of Schedule:** In the Schedule attached to the principal Junior Librarian (Law) Recruitment Rules, 2020 :
 - In column 10, for the existing entries, the entries “100% by Deputation/Absorption” shall be substituted.
 - In column 11, for the existing entries, the entries “Transfer on deputation/absorption from the Central/ State/PSUs, who has completed 3(three) years of regular service in the grade of Junior Librarian” shall be substituted.
